Message from the Vice-Chancellor University of Kelaniya Senior Professor Nilanthi de Silva

It is with great pleasure that I send this message of felicitation to the Kelaniya University Alumni Association in Australia on the occasion of celebrating your 15th Anniversary.

The University of Kelaniya is now among the largest of the state universities in Sri Lanka, with a proud history of over 60 years. Over this period, we have produced many graduates in the Humanities and Social Sciences, Sciences, Social Sciences, Medicine, and Commerce & Management Studies. At present we have an undergraduate student population of about 14,500 registered in six different Faculties scattered in 3 different campuses in Dalugama, Ragama and Peliyagoda.

The turbulence brought about by the COVID19 pandemic and the acute political crisis of 2022 have now somewhat subsided, but as a state-funded national university, we still feel the dire impact of the economic collapse that precipitated last year's political crisis. We are therefore particularly appreciative of the generosity of our Alumni Associations that have come forward to support the University of Kelaniya in numerous ways, especially those relating to student welfare.

The Kelaniya University Alumni Association in Australia has been one of the most supportive, and I have every confidence that you will continue to support your alma mater in the future too. I hope that the KUAA might consider some fund-raising activities that will help the university to find the necessary financial resources for renovation and refurbishment of the Gym canteen.

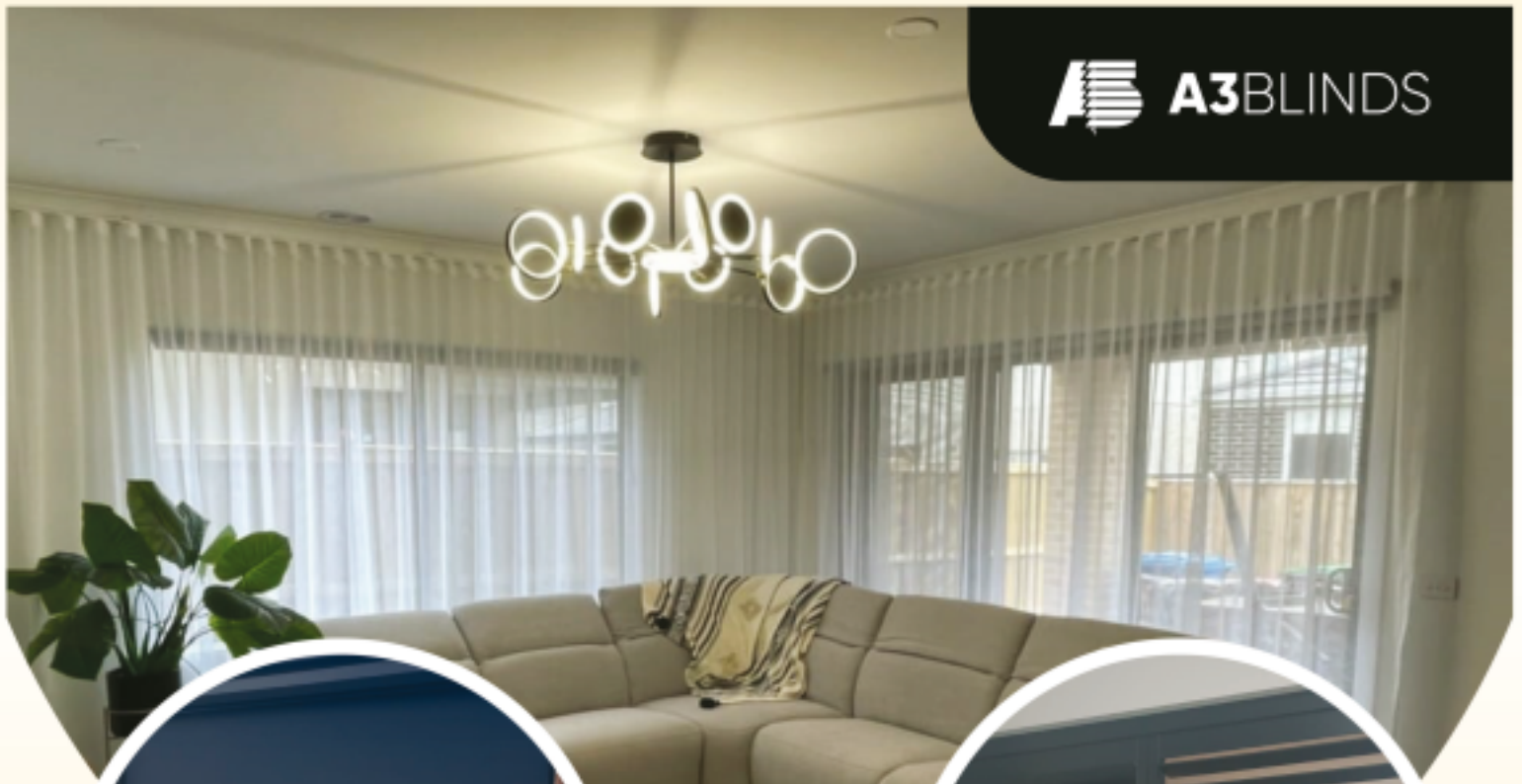
